SECTION 4 First Aid Measures

Eye Contact: Rinse with running water for 15 mins. Hold eyelids apart while irrigating. Get medical attention.

Skin Contact: Flush contaminated skin with plenty of water. Remove contaminated clothing. Launder clothing before reuse. Leather goods shall not be reused, but rather destroyed. Chemical burns must be treated promptly by a physician.
